# THE EGLWYS BREWIS CHURCH STEERING GROUP

The above meeting was held on Friday 28<sup>th</sup> September, the following points are of interest to St Athan.

- 1.Jane Hutt AM stated that, Determination of the future uses for the Church Farmhouse and Barn would produce extensive benefits to the 750 employees of Aston Martin and there will be benefits to tourism by these buildings historic and cultural importance.
- 2. The important aspects of this meeting are that;
- a. Aston Martin are interested in the Farmhouse (for the purpose of training and accommodation) Negotiations for their acquisition of this could encompass their benevolent concern for the use and presentation of the Church and adjacent barn.
- b. It is understood that the appropriate Welsh Government Cabinet Secretary has given his preliminary approval for the recommendation to dispose of these buildings
- c The Executive Committee of the Friends of Friendless Churches confirmed that they wished to take on ownership of the Church.
- d. The MOD had met last week and given that the Friends of Friendless Churches clearly meet MOD requirements for a "responsible owner" the recommendation is, that the Church could be disposed of free of charge, as seen and without any preliminary refurbishment. e. Friends of Friendless Churches are to set up a trust, it is important that the Trustees are local people, individuals who are not currently represented at these meetings but who may well come forward as the project is promoted and gathers pace.
- 2. This Steering Group has many "sub-groups" dealing in research for funding, transfer of the assets from, the MOD and Welsh Government, restoring the building etc, the minutes of the meeting are extensive if you would like to read them in full please contact B Acott.

## FOOTPATH FORUM LLANTWIT MAJOR TOWN COUNCIL

The above meeting was held on Monday 1<sup>st</sup> October, the following points are of interest to St Athan pending the publishing of the full minutes.

- 1. The Rights of Way Officer Vale of Glamorgan Council gave updates on:

#### Report by B Acott

## ABERTHAW POWER STATION LOCAL LIAISON COMMITTEE

The above meeting was held on Tuesday 25 September, the following points are of interest to St Athan pending the publishing of the full minutes.

- 1. Their excellent safety record was spoilt recently when an employee suffered a crushed hand
- 2. During the Cold weather in March (The Beast from the East) Aberthaw supplied the National Grid with all three units for full period.
- 3. They missed out in the Capacity Market auction for 2021-2022 but will submit a bid for the 2023-2024 Capacity market.
- 4. The markets are tough for coal powered stations but Aberthaw will put up a good case.
- 5. This year they will provide generation, as required, from October to April 2019.
- 6. Coal is purchased from the World market, mainly Russia, with coal delivery trains to the site now at less than 10 per week.
- 7. The expected end of coal powered station is 2025, but the country may well still need coal powered stations, Aberthaw is safe to the end of 2021.
- 8. Aberthaw is the subject of the BBC TV program "HIDDEN WALES" to be broadcast in December.
