In addition why was it deemed necessary to add the no entry signs to the junction. • Cllr S Williams explained, the new additional lane is causing confusion and it felt unsafe too be stopped in the box in the middle of the road, particularly so when crossing from Gileston. • Cllr J Lougher suggested a Pelican type crossing is installed and that consideration should be given to utilising the ‘safe routes to schools fund’ to pay for this improvement. • Cllr J Angove asked what more resources were available to make it safe. In addition how the Council record near misses and what other measures can be put in place to make the monument junction safe. 	CARRIED

White mentioned that she had received lots of complaints from residents following the recent works too this junction, with instances of people turning into the village facing oncoming traffic as had used the wrong lane due to the dog leg nature of the layout. In addition, those joining the B4265 from St Athan have much more restricted visibility with another vehicle turning right and/or some signage poles obscuring traffic coming from Llantwit Major. • Cty Cllr J Thomas suggested more permanent 'No Entry' signs should be installed to replace the current makeshift signs. • Cllr R Eustice commented that we have a lot of potential future development with a 50% increase in housing in the LDP. In addition, the new homes built on the Gileston side of the junction did create more people movements across it, to access the Village. <p>Emma Reed acknowledged the points raised and confirmed the monument junction has been the subject of a road safety audit. She commented that the works were part of the new development, but no more funding available, new junctions do take time to settle in. St Athan Community Council Update Tuesday 6 th July 2021 – 7.30pm Emma Reed Head of Neighbourhood Services and Transport

Background

In advance of the meeting I provide the following updates related to matters for me on the agenda.

Monument Junction St Athan

An assessment has been made of the personal injury casualty data within a 50- metre radius of the 'Monument' junction, which encompasses the pedestrian path and central refuge enabling a split crossing movement between St Athan and Gileston over the B4265. The assessment examined the five-year period up to 25th June 2020 (the latest official data supplied to us by Welsh Government). During that time three slight-severity personal injury collisions (PICs) are recorded to have occurred:

1. The first PIC occurred just before midnight in September 2015 involving a car turning right from B4265 into St Athan into the path of a car on B4265 approaching from Llantwit Major. There is no suggestion in the police report of excessive speed.
2. The second PIC occurred just after lunch time in February 2017 involving a car turning left from St Athan across the give way lines which was immediately struck by a car on B4265 approaching from Llantwit Major. There is no suggestion in the police report of excessive speed.
3. The third PIC occurred just after lunch time in October 2017 involving a car turning right from Gileston across the give way lines which was immediately struck by a car on B4265 approaching from Rhoose. There is no suggestion in the police report of excessive speed.

More recent data has been obtained in light of recent concerns of two accidents at the Monument as follows:

1. There was a recent incident involving a child at this junction. The incident occurred at 17:22 hrs on 6th May 2021. A police officer was on patrol in the area and attended the incident. He spoke to the driver of the car involved and to the child aged 9 years who was in the presence of his/her mother. It appears the child ran into the road near the junction at the monument. The driver stated that he/she was driving at a very low speed at the time of the collision as he/she had already observed that the child appeared apprehensive about crossing at the location. The child struck the bumper of the car causing him/her to fall to the floor, however there was no recorded injury as a result. The mother of the child and the driver were known to each other and details were exchanged. The collision was reported by the police officer as minor in nature, though an ambulance was in attendance but not required.
2. One other collision at the junction has also been recorded up to and including 22nd June 2021. The PIC occurred in April 2021 involving two vehicles. The first vehicle was waiting to turn right onto Gileston Road and the second vehicle was travelling eastbound towards Rhoose. The two vehicles collided while one was turning causing minor injuries to one person. The Police Traffic Management Officer commented that visibility on approach to the junction is good from both directions and added that there are advanced direction signs on both approaches indicating the presence of the junction to drivers. On the issue of whether a

lowering of the current speed limit would be appropriate, the officer expressed doubt regarding the likelihood of achieving driver compliance on the basis that both approaches are in a primarily rural setting.

The Council will continue to liaise with the Wales Casualty Reduction Partnership, GoSafe to ask for an assessment of the current situation, with a request that speed camera enforcement should follow if practical and appropriate.

Swan Neck Turn Monument Junction

With regards to the “swan neck turn” when driving from Gileston to St Athan, as you can see from the earlier data above, there is no record of any such collision occurring involving that manoeuvre in the 6 year study period. When negotiating any crossroads junction, care and moderate speed is required while drivers do so.

Pedestrian Refuge Crossing Monument Junction

In terms of crossing the road to access the facilities in St Athan, except for the recent incident, there is no record of any injuries occurring to pedestrians. The pathway route across B4265 already has a kerbed central island which is as wide as can be accommodated given the available carriageway width. The refuge is further protected from vehicle incursion by a hatched area, with additional red surfacing to emphasise its presence to approaching drivers.

Roundabout Request

In respect of a request for a roundabout to be provided, such a change would incur significant expenditure if included as part of the Council’s Capital Programme. In deciding about how best to allocate the limited capital funds we have available we are particularly mindful of locations where serious and fatal collisions have already occurred.

To set that statement into context, **in the ten years to 2019 the Vale area suffered from a total of 1,865 PICs, regrettably including 21 fatalities and 238 serious injuries.** The same period included a lengthy period of recession and less funding available including that available to introduce road safety improvements. However, using the targeted approach we have adopted, which includes prioritising changes in areas where serious and fatal injury collisions have already occurred, **we have contributed to a fall in overall injury collisions occurring within our area from 214 in 2010 to 132 in 2019.** In such circumstances using the history of injury collision severity represents an important part of our approach in dealing with the numerous complaints that we continue to receive daily. As such, I am unable to justify at this time adding proposals to change the junction to a roundabout to our Capital Programme at the present time.

Traffic Speed and 20 mph limit in St Athan Village and Surrounds

I would advise that whilst the Council has a statutory responsibility under Road traffic Act to make the highway safe as far as reasonably practicable, the specific enforcement of traffic speed is the responsibility of the South Wales Police (SWP) and GoSafe. As such, I am aware that following previous representations from the Council, **GoSafe have designated Cowbridge Road as one of their top priority sites for safety camera enforcement, agreeing to attend there with the camera van for a minimum of 7.5 hours each month before the lockdowns began.**

An investigation into the personal injury collision record for the 3 year period up to 25th June 2020 (the latest police data supplied to us by Welsh Government), covering the main road through St Athan from Gileston Cross to New Barn, some 500m north of the junction to Eglwys Brewis, **has revealed that no injury collisions have been reported to have occurred during**

that extended period of time. The collision data does not therefore suggest a basis for a business case to attract appropriate funds to carry out intervention measures along the route. The locations for pilot 20mph sites as part of the Welsh Governments proposals to implement a future default 20mph speed limit in Wales has already been fully allocated and agreed with Transport for Wales who coordinating the arrangements with various Councils.

Generally, the Council's current position to wait for the implementation the above-mentioned default 20mph limit for Wales anticipated in April 2023 and which will have the support of the South Wales Police other than progressing separate ad hoc roll out of such arrangements.

Recently the Council has agreed to introduce a further two 20 MPH experimental speed limit schemes in this financial year and have chosen these due to either considerable s106 planning gain funding being available or the location being put forward previously to WG for the pilot scheme but being unsuccessful. The Council currently does not have sufficient funding to consider any further roll outs this financial year. Whilst offences continue GoSafe will hopefully continue to visit and monitor the location regularly in future. This should have an impact of excessive speeds all along Cowbridge Road and into St Athan village and should help to address the hope that this clarifies the Council's position.

Active Travel Update – St Athan Proposals Link to consultation for St Athan active travel routes which closes on 8th July:

In summary the project will consist of the following elements:

- 3m wide tarmacadam shared used pathway along a large proportion of the route
- Pathways marked as shared use
- Replacement bus shelter to include digital display board
- Vehicle activated speed warning signage
- Dropped kerbs and tactile paving

The measures will deliver a safer pedestrian and cyclist environment, particularly for vulnerable road users and school pupils, and will improve accessibility to the community area.

Subject to the outcome of the consultation, construction is due to start early August 2021 and will be completed February 2022

VALE OF GLAMORGAN LIASION COMMITTEE MEETING 5TH JULY 2021
REPORT BY COUNCILLOR A BARNABY

The Agenda covered the following items:

- 1) **Police Matters** - Chief Inspector Arabella Rees was welcomed and gave a brief overview of recent crime figures, as with last report, public order offences relating to Covid rules were still an issue, while theft was down, domestic theft had started to increase, no doubt as residents start going back to work, going on holiday etc., Following the last Liaison meeting she had asked for contact with Town and Community Councils to resume. However, several members present stressed this had not happened, including Cllr A Barnaby for St Athan. A question was raised regarding the re-starting of PACT meetings, it appears these had continued 'on-line' but would need to report back who receives the invite.
- 2) **South Wales Fire and Rescue Service** - gave a presentation on the activities of the fire service, included was highlighting where a 'controlled' burn is allowed in the garden it should be garden waste only, a reduction in capacity due to Covid illness has reduced. The fire cadet programme that has been suspended due to Covid is now re-opening in September, they have organised 3 keeping in touch events.
- 3) **Public Service Board (PSB) Annual Report** - was presented by Tom Bowring and Cllr Cuddy. This covered the current elements of effects of climate change and well-being. Cllr A Barnaby commented that these were both of interest to residents, but there is a risk of it becoming a 'tick box' exercise unless all department endorse the principles, especially in planning – such as our communities concerns regarding the number of houses being built, without being linked to 'actual' job creation at the St Athan Enterprise Zone, which will result in massive increase in commuting, plus the WG not investing in 'clean' industries, at the site.
- 4) The Scrutiny Committee report was presented to the meeting. Highlighted was agenda size leading to long meetings and use of standing orders. Clerk training had taken place, endorsing the networking to share good practice started in 2019.

POLLINATOR PROJECT & BT EXCHANGE BUILDING
REPORT BY COUNCILLOR D WHITE

Pollinator Project

Aim: To assist St Athan to become a pollinator friendly village in the Vale. Support national B Lines network (see [bug life.org.uk](http://buglife.org.uk))

Raise importance of pollinators and wildflowers whilst improving the appearance of the village.

Seeds can be sown by hand and treaded in so they have good contact with soil. Plug plants can be planted into existing grassy areas. Great engagement activities for both children and adults.

We have identified community council land that could be used from Gileston, side of road, cenotaph (purely poppies) assistance from school, through to Flemingstone green. The Vale Council representative happy to assist us with regard to Vale land which would be incorporated into their mowing schedules.

Activity best undertaken in the Autumn.

Smaller private areas such as Spar, the hairdressers, local pub all happy to come on board.

BT Exchange building

Confirmation has been received from BT, that the necessary works to the exchange building will be carried out by BT Property services and will include repainting of doors and entrance gate. Grass cutting and treatment of weeds to commence Friday 9th July 2021.
